The Family Welfare Committees shall look into every complaint under section 498A IPC or any matter involving the provisions of section 498A IPC as referred to by police or by a Court of Judicial Magistrates and the Committees shall have power of interaction with the parties personally or by means of telephone or by any other means of communications including electronic communications. The Family Welfare Committee shall furnish its report to the authority by which the complaint is referred to it latest within one month from the date of receipt of complaint/reference and for that purpose the Committee may give brief report about the factual aspects and its opinion on the matters for consideration of the investigating officer or of the Court concerned on its own merit.

The Chairman or the Members of the committee shall have to undergo basic minimum training as would be imparted by the Tripura State Legal Services Authority in co-ordination with the Tripura Judicial Academy time to time on by the Legal Services Authorities/committee time to time.

The Family Welfare Committees will initially work for a term of one year from this date.

The activities of the Family Welfare Committees shall be subject to monitor by the District & Sessions Judge, North Tripura, Dharmanagar, being the Chairman of the District Legal Services Authority.

The respective Chairman of the Family Welfare Committees shall receive monthly honorarium of Rs 6000/- and each Member thereof shall receive monthly honorarium of Rs 5000/-.
