The Govt. of Tripura vide *Notification dated 13.08.2008*, has constituted Tribunals in the *17 Nos. of Sub Divisions of the State* under section 7 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 and thereafter the Govt. of Tripura vide another *Notification dated 11.07.2012* has constituted more *06 Tribunals in 06 other Sub Divisions of the State* under Section 7 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 authorizing the Sub-Divisional Magistrates as the Tribunals and also the Govt. of Tripura vide *Notification dated 14.08.2008*, has constituted *04 Nos. of Appellate Tribunals in the 04 Nos. of Districts of the State* authorizing the District Magistrate and Collector as the Appellate Tribunals and after that *vide another Notification dated 11.07.2012*, the Govt. has further constituted *04 more Appellate Tribunals in 04 other Districts* authorizing the District Magistrate and Collector as the Authority of the Appellate Tribunals under Section 15 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007.
